IMPORTANT

SAFETY TIPS FOR VOLUNTEERS

- Stay away from large drums or buckets. Report their location to the cleanup zone captain.
- Wear gloves to collect the debris.
- Be careful of glass, syringes or other sharp objects.
- Don't lift anything heavy.
- Stay out of dune areas.
- Avoid stepping on beach grasses.
